## 40 Year Reunion for the School of Hospital Administration Class of 1964

ctober 2-5, 2004, in Tarpon Springs, Florida, the Class of 1964 gathered together to reminisce about old times, class room antics, and their lives both inside and outside of what originally brought and kept them all together over the years – their interest in health care, their health care education and their health care professions. Continuing to building memories and to strengthen their cohesiveness that started long ago, they gathered once again to solidify their goal of staying together in friendship. Social activities a plenty, much fun was had by one and all.



A tremendous group of individuals who can reflect back over distinguished professional accomplishments with pride, it's fun to look back and think...


When they came to the Hospital Administration Program at the Medical College of Virginia, most were older and married. Many had at least a few years of work experience under their belts, and many had military experience. Of the 15 classmates, all were male, and about a third were from Richmond, a third were from areas of Virginia other than Richmond, and a third were from out of state. Few had parents helping to support them, and nearly all paid their own tuition. Loans and scholarship monies were slim to none. They were paying for what they were learning, and grasping every opportunity to learn.

When they came to the Program, it was only 14 years old, only about 130 graduates to date. Robert S. Hudgens, the Arthur Graham Glasgow Professor and the Director of the School of Hospital Administration, was one of only a true handful of full time faculty. Other faculty were adjunct, all in another health care operational jobs, with many donating their time to teaching. All professors and lecturers came to them. All classes were taught in one classroom. Business attire was required, as seemingly were briefcases.

When they came the Program, hospitals were thriving. Hill Burton dollars had built many new hospitals, and the demand for strong health care leaders to lead these facilities was high. Cost based reimbursement was still the name of the game. Camaraderie amongst hospitals high. Everyone got a good residency, with ease.

When they graduated, they left with not only strong ability to listen, respond, analyze and react to health care matters, but also a true and real sense of ethics and values, and an understood mission toward hospital administration. With big changes around the corner, most prominent being the establishment and implementation of Medicare, classmates in their early careers saw realities materialize in their life true to form from what they were lectured upon and what they learned.

Gathering again 40 years after their graduation, there's much for this group to be proud of professionally: one remained almost 40 years in the same setting; one became the Assistant to the Surgeon General of the USAF; one got a PhD and founded and then sold the Governance Council; one became a Vice President of HCA and a most successful hospital administrator and executive in residence at MCV; one owns his own hospital and a durable medical equipment company, and lectures as an adjunct professor at Southern Mississippi University; one remained in hospital administration from 1964 to 1979 then went to become a most successful entrepreneur in trucking, banking, & construction; one became President of Humana's Hospital Division, the Civilian Consultant to the Surgeon General of the USAF and a Professor Emeritus/Executive in Residence at MCV; and the others fulfilled an extremely strong role in the profession of hospital administration in their respective communities and State, fulfilling a true, real and noble productive role in their profession.

At this gathering, there was much for classmates to remember and cherish. The chemistry of the group, and classmates' affection for their school and the faculty who taught them. Classmates and their spouses who have passed away, but are never forgotten. And the Department of today is not only proud of their professional accomplishments and what they have done to shape our health care system of today, but salutes them and is proud of their loyalty toward each other and to the Department Program, faculty, students and fellow alumni/ae.

## Alumni/ae Survey and Activities Update

his past fall, the Department conducted an alumni/ae survey with the assistance of the MCV Foundation. Many thanks to the Foundation and the 235 alumni/ae who completed this survey, as the survey responses have given the Department valuable input and insights into alumni/ae perspectives. Below is a recap for some survey information.

#### **Survey Questions and Answers**

#### What is your current attitude towards the Department?

On a scale of 1-5, with 5 being very positive, 4 positive, 3 neutral, 2 negative, and 1 very negative, 231 alumni/ae responded yielding an average of 4.5 and median of 5.0.

#### How aware are you about the reputation of the Department, for example, the Department is ranked #5 in the Nation?

On a scale of 1-4, with 4 being very aware, 3 being somewhat aware, 2 being vaguely aware, and 1 being unaware, the responses of 231 alumni/ae responded yielding an average score of 3.4 and median of 4.0.

#### When you think about the Department, how interested are you in its future?

On a scale of 1-4, with 4 being very interested, 3 being somewhat interested, 2 being a little interested, and 1 being not interested, 231 alumni/ae responded yielding an average score of 3.6, and median score of 4.0.

#### Would you recommend the Masters Programs to qualified, prospective students?

On a scale of 1-4, with 4 being definitely yes, 3 being probably yes, 2 being probably no, and 1 being definitely no, 231 alumni/ae responded yielding an average score of 3.8, and a median score of 4.0.

#### Among the various philanthropic causes that you support, how would you rank Health Administration?

On a scale of 1-5, with 5 being the highest, 4 being high, 3 being middle, 2 being low, and 1 being lowest, 225 alumni/ae responded yielding an average score of 2.9 and median score of 3.0.

#### What level of importance do alumni/ae place on goals and objectives set as priorities by the Chair of the Department?

On a scale of 1.5, with 5 being the highest, 4 being high, 3 being middle, 2 being low, and 1 being lowest, alumni/ae responded yielding the following average and median scores, in italics and underlined, respectively:

Student Scholarships – 3.8 4.0

Endowed Professorships  $-3.9 \pm 4.0$ 

Williamson Institute -3.7 4.0

Endowed Operating Funds -3.8 + 4.0

Facilities and Building -3.7 4.0

Department Self Reliance – 3.9 4.0

#### Questions and Answers Based on Alumni/ae Survey Comments

#### Why aren't the Programs called the Medical College of Virginia health or hospital administration programs anymore?

In 1968, when Virginia Commonwealth University was formed from the merger of the Medical College of Virginia and the Richmond Professional Institute, the plan always was to unite the two units into a single entity. Senior administration has since decided that the only effective way to achieve this goal is to have a single name for the entire University. Neither the Department, nor the MCV Alumni Association, has had any way to influence this decision.

## What's the difference between the Department of Health Administration Alumni/ae Association and the Medical College of Virginia Alumni/ae Association (MCVAA)?

Membership in the Department of Health Administration Alumni/ae Association is automatically conferred upon all persons who satisfactorily completed a Department graduate or undergraduate degree program or who have been conferred honorary degrees. There are no dues.

The MCVAA is a separate organization. Associate Membership in MCVAA is automatically conferred upon all graduates of programs housed on the Medical College of Virginia Campus of VCU. Active membership is conferred annually on (continued)

those alumni paying annual dues to the MCVAA. Honorary memberships may be granted to persons by action of the Board of Trustees.

The MCVAA is located in the Alumni House at 1016 East Clay Street, right next to the Department's Grant House, and includes an adjacent conference center, funded by a donation from Paul A. Gross (MHA '64). Please visit the MCVAA website, www.vcu-mcvalumni.org, to learn more about the MCVAA dues structure; exclusive benefits association members receive, including but not limited to low cost internet services, discounts on car rentals and hotels and certain recreational facilities; the ability to post resumes and job postings, and to review job postings; mentoring and volunteer opportunities, and MCVAA's calendar of events and alumni information.

## When I make a donation to the Department, does that enroll me in the Medical College of Virginia Alumni/ae Association?

No. When you make a donation to the Department, you may designate how the Department is to use your money. If you want to join the MCVAA, contact them via their website under membership, or call them at (804) 828-3900.

#### What does the Department do for me today, and what are the benefits of staying connected with the Department?

The Department is always trying to stay connected with its alumni/ae and keep them involved, recognizing that this is a win-win partnership. Initiatives to accomplish this include the development and updating of our website, the production of alumni/ae directories and *Cardwell Comments* newsletters, representation at national conferences such as ACHE, MGMA, and AcademyHealth, and alumni/ae gatherings, such as the Cardwell Reception at ACHE, the Paul A. Gross Landmarks in Leadership lecture series, and regional gatherings. The Department also spends much time trying to maintain the best possible contact information on its alumni/ae, maintaining an alumni/ae database in house. Somewhat unique among VCU departments, the Department has had a Director of External Relations in place for almost 5 years. This part-time position is not a state funded position, but funded by the Department because the Department believes alumni/ae should have a point person at the Department.

To try and enable and foster alumni/ae and Department connections, the Department works closely with your elected Alumni/ae Executive Committee and its subcommittees to ensure that alumni/ae have strong input into students' curriculum, the Cardwell Society fundraising, recognition of an Outstanding Alumni/ae each year, and many other Department initiatives. The Department welcomes alumni/ae participation on Department committees, like the MHA admission committee and curriculum subcommittee; with guest lectures; with student employment; and with residencies and oral comprehensive seminars.

#### Why doesn't the Department offer more career planning and placement services?

The Department is aware that there are alumni/ae who are looking for career and planning and placement services. Job opportunities are posted on our website, <a href="www.had.vcu.edu">www.had.vcu.edu</a> under employment opportunities. If you know of a healthcare position within your organization, please send this posting to Amy Edwards, <a href="mailto:anedwards@vcu.edu">anedwards@vcu.edu</a>, for placement consideration. If you have other career questions, please contact Ms. Edwards.

The Department is also seriously considering the development of a career planning and placement service for alumni/ae. This would be a major addition to the already extensive activities that the Department undertakes, and a particular barrier to overcome will be to find a reliable funding source for this service.

## Student scholarships were not available when I attended the program. Why does the Department ask for money for student scholarships?

In the last 5 years, it is true that the Department asked, and alumni/ae have graciously responded, to appeals for money for student scholarships. Tuition and fees at VCU have soared. So have costs for books and reading packets. In 2004-05, instate tuition and fees for MHAs and PHDs are now \$7,707, over a 41% increase in only three short years, and an almost 100% increase in only three short years. For this same time, in-state tuition and fees for MSHA are now \$10,059, over a 25% increase in only three short years, and an almost 100% in fourteen years. Out-of-state tuition and fees are \$18,132 per year for MHAs and PHDs and \$19,937 for MSHAs. The cost of books and reading packets for one year is about \$1,000. To help ensure that the best and brightest students interested in pursuing health care careers choose VCU, scholarship money will remain an important Department objective, as will endowed professorships, to ensure the Department can attract and retain high caliber faculty to teach these same student.

It is also important to note that the vast majority of MHA students work part time in order to defray the costs of their education, even with the addition of scholarship awards. The tradition of working part time in health care organizations while attending classes still continues!

## Alumni/ae Spotlights

eter C. Olden (PhD '94) is an Associate Professor & Director, Graduate Health Administration Program, University of Scranton. After 15 years in executive positions at a southeastern community hospital, teaching hospital, and then regional medical center, Mr. Olden initiated a career change in 1990, beginning work on his Ph.D. in Health Services Organization and Research, which he completed in 1994. Since 1993, Dr. Olden has been teaching at the University of Scranton where he is now Associate Professor and Director of the Graduate Health Administration Program. He has taught courses on health care organization, management, strategic planning, policy, marketing, human resources, and the U.S. health care system. r. Jonathan Perlin (MSHA '97) was appointed Acting Under Secretary for Health in the Department of Veterans Affairs on April 6, 2004. As the Chief Executive Officer of the Veterans Health Administration (VHA), Dr. Perlin leads the nation's largest integrated health system. The VHA provides health care to over 5.1 million Veterans, and 7.6 million enrollees, throughout the United States. With a medical care budget of \$27.4 billion, VHA employs directly employs over 193,500 health care professionals at 158 hospitals, more than 850 community and facility-based clinics, 135 nursing homes, 43 domiciliaries, 206 readjustment counseling centers, and various other facilities. A Fellow of the American College of Physicians, Dr. Perlin also received his Ph.D. in pharmacology and toxicology (performing research in molecular neurobiology) with his M.D. as part of the Medical Scientist Training Program at Virginia Commonwealth University's Medical College of Virginia Campus. A preceptor and strong Department supporter, the Department is pleased that Dr. Perlin



will be the 2005 Landmarks in Leadership Speaker on May 5, 2005 during the special segment of the Paul A. Gross Distinguished Leadership Lecture Series.

tephen "Steve" Gravely (MHA '80) is currently a partner with the law firm of Troutman Sanders LLP. In his legal practice, Mr. Gravely specializes in Health Care, Intellectual Property, Governmental Law, and Special Investigations. Mr. Gravely serves in the Health Law sections of the American Bar Association, the Virginia State Bar, and the Virginia Bar Association. He is also a member of the American Health Lawyers Association, the Health Care Compliance Association, the Health Care Financial Management Association, the American Public Health Association, and the Central Virginia Health Care Executive Group. In 2003, Steve Gravely was named to Virginia's Legal Elite in Health Care. Steve received his B.A. from the College of William & Mary in 1977 and his MHA from VCU/MCV in 1980. He went on to earn his J.D. from the University of Richmond in 1983. Prior to practicing law, Mr. Gravely had experience in hospital operations with



Williamsburg Community Hospital, Riverside Hospital and Healthcare System, Blue Cross Blue Shield of Virginia, Southside Regional Medical Center, and Richmond Memorial Hospital. A member of the Admissions Committee and participant for third year MHA oral comprehensives, the Department is so pleased Steve remains so active in many facets of Departmental affairs.



## **Dr. Kelly Devers Joins HAD Faculty**

ffective **July** 2004, Dr. Kelly Devers joined the Department faculty as an Associate Professor. Dr. Devers conducts research on a wide range of organization and policy issues. Her recent research has focused on hospitals' and medical groups' response to changing market and policy forces and their impact on cost and quality and patient safety. She also is an expert in qualitative and mixed research methods. Currently, she is a co-investigator on a congressionally mandated study conducted through the Center for Medicare and Medicaid Services (CMS) on physician-owned specialty hospitals and an Agency for Healthcare Research and Quality (AHRQ) funded project examining physician office-based supports to improve smoking cessation counseling. She also serves as task leader on an AHRQ funded H-CAHPS project on physician-patient communication about hospital quality data and its implications for hospital referral and choice. Dr. Devers has published widely in major health services research



and policy journals and served as guest editor of *Health Services Research*, edited a book on managed care, and is currently co-authoring a textbook on mixed methods research. She also is a temporary member of the Health Services Organization and Delivery (HSOD) study section, National Institute of Health (NIH). Dr. Devers teaches courses in health care organization theory and in quality and patient safety. She holds a joint appointment in the VCU School of Medicine, Department of Family Practice. Dr. Devers received her Ph.D. is sociology from Northwestern University.



# Jacqueline Zinn, Ph.D. Visits the Department


he Department of Health Administration was pleased that Jacqueline "Jackie" Zinn, Ph.D., came to the MCV Alumni/ae House November 4-5, 2004 to be the guest lecturer at the Paul A. Gross Distinguished Lecture series. Dr. Zinn is a Professor of Health Care Management from Temple University and is a nationally known expert on the organization and financing of long term care. During her stay, Dr. Zinn met with faculty, doctoral students and invited guests, and presented her lecture entitled "Driven to Tiers: Disparities in the Quality of Nursing Home Care."

Dr. Zinn joined the Fox School at Temple University in Philadelphia, Pennsylvania after a successful career as a hospital administrator at Temple University Hospital and The Hospital of the University of Pennsylvania. At Temple, Dr. Zinn teaches both undergraduates and graduate students in healthcare, strategic management and business policies.

Dr. Zinn is the 1996 recipient of the John D. Thompson Prize for research achievement, the 1997 corecipient of a Robert Wood Johnson Clinical Investigator Award, and the recipient of the 2000 Andrisani-Frank Award for Excellence in Teaching. She has over fifty peer-reviewed research articles and eighty scientific presentations examining the influence of market competition and organization characteristics on quality and access in health care settings, comparing severity adjusted outcomes of care.
